GLIMCHER REALTY TRUST BOARD OF TRUSTEES DECLARES THIRD QUARTER DIVIDENDS FOR 2007

COLUMBUS, Ohio—September 6, 2007—Glimcher Realty Trust (NYSE: GRT), one of the country’s premier retail REITs, today announced that the Company’s Board of Trustees has declared a cash dividend of \$0.4808 per common share for the third quarter of 2007. The cash dividend is payable on October 15, 2007 to shareholders of record on September 28, 2007. On an annualized basis, this is the equivalent of \$1.9232 per share.

In addition, the Company declared a cash dividend of \$0.5469 per Series F preferred share of beneficial interest for the third quarter of 2007. The cash dividend is payable on October 15, 2007, to shareholders of record on September 28, 2007. On an annualized basis, this is the equivalent of \$2.1876 per preferred share.

Finally, the Company declared a cash dividend of \$0.5078 per Series G preferred share of beneficial interest for the third quarter of 2007. The cash dividend is payable on October 15, 2007, to shareholders of record on September 28, 2007. On an annualized basis, this is the equivalent of \$2.0312 per preferred share.

Glimcher Realty Trust, a real estate investment trust, is a recognized leader in the ownership, management, acquisition and development of regional and super-regional malls, and community shopping centers.

Glimcher Realty Trust’s common shares are listed on the New York Stock Exchange under the symbol “GRT.” Glimcher Realty Trust’s Series F and Series G preferred shares are listed on the New York Stock Exchange under the symbols “GRT.F” and “GRT.G,” respectively. Glimcher Realty Trust is a component of both the Russell 2000[®] Index, representing small cap stocks, and the Russell 3000[®] Index, representing the broader market.
